To LKSD Families in Bethel -

As Bethel schools will be operating under a fully remote model for the week of August 24<sup>th</sup> – August 28<sup>th</sup>, one breakfast and one lunch will be available to any enrolled LKSD student for each instructional day of that week. Distribution of these meals will take place with our Meals on the Bus program on the same schedule that we followed during our school closures last spring.

One key difference from the program operation in the spring is that we will only be able to offer meal service to children who are *currently enrolled at an LKSD school*. Unfortunately, at this time, we are not able to provide meals for younger siblings of enrolled students, Head Start students, or students enrolled at any boarding schools such as Mt. Edgecumbe, Galena Interior Living Academy, or Nenana Student Living Center.

Staff on the buses will have rosters updated daily from each Bethel site with the most current list of enrolled students for that site. If you have questions about your child's enrollment, please contact their school.
